RE: PLANNING & DEVELOPMENT ASSESSMENT

This assessment pertains to the boundary reconfiguration of lot 1 on MPH20514, located at 18 Phillipson Road, Millchester.

Please accept the enclosed DA form 1 and proposed reconfiguration plan on behalf of the applicant Mr. Kieran Russell.

We are seeking a development permit to reconfigure the existing residential allotment boundaries in the following manner:

- Lot 1 at 903 m2 &
- Lot 2 at 1120 m2.

The subject land comprises a total area of 2023 m2 and contains an existing dwelling & associated sheds. Under the Charters Towers Regional Town Plan, this lot falls in the general residential zone code. The subject lot has two road frontages, along Phillipson Road and Natal Street, which are both sealed. The existing dwelling has connections to town services via Phillipson Road.

The applicant wishes to realign the boundaries in a manner as to create two lots, giving Lot 1 whole of the frontage along Phillipson Road, and Lot 2 frontage along Natal Street. These two proposed lots comply with all minimum requirements and are suitable for the residential zone code.

The registered owner of Lot 1 on MPH20514 is Mr. Paul Russell (see attached certificate of titles).

Under the Charters Towers Planning Scheme, the proposed development requires assessment against the following codes:

- Reconfiguring a Lot Code
- General Residential Zone Code
- Development Works Code

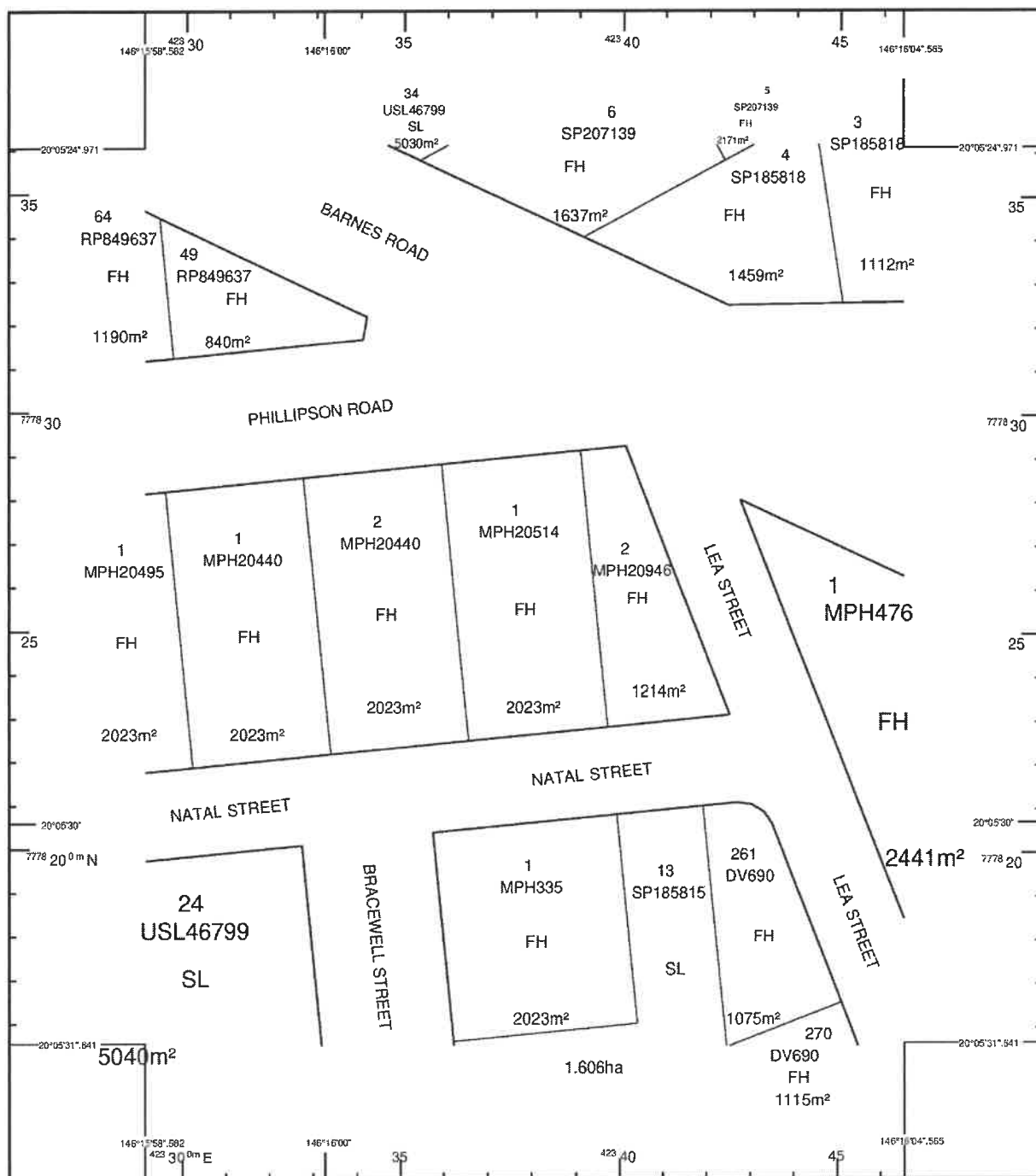

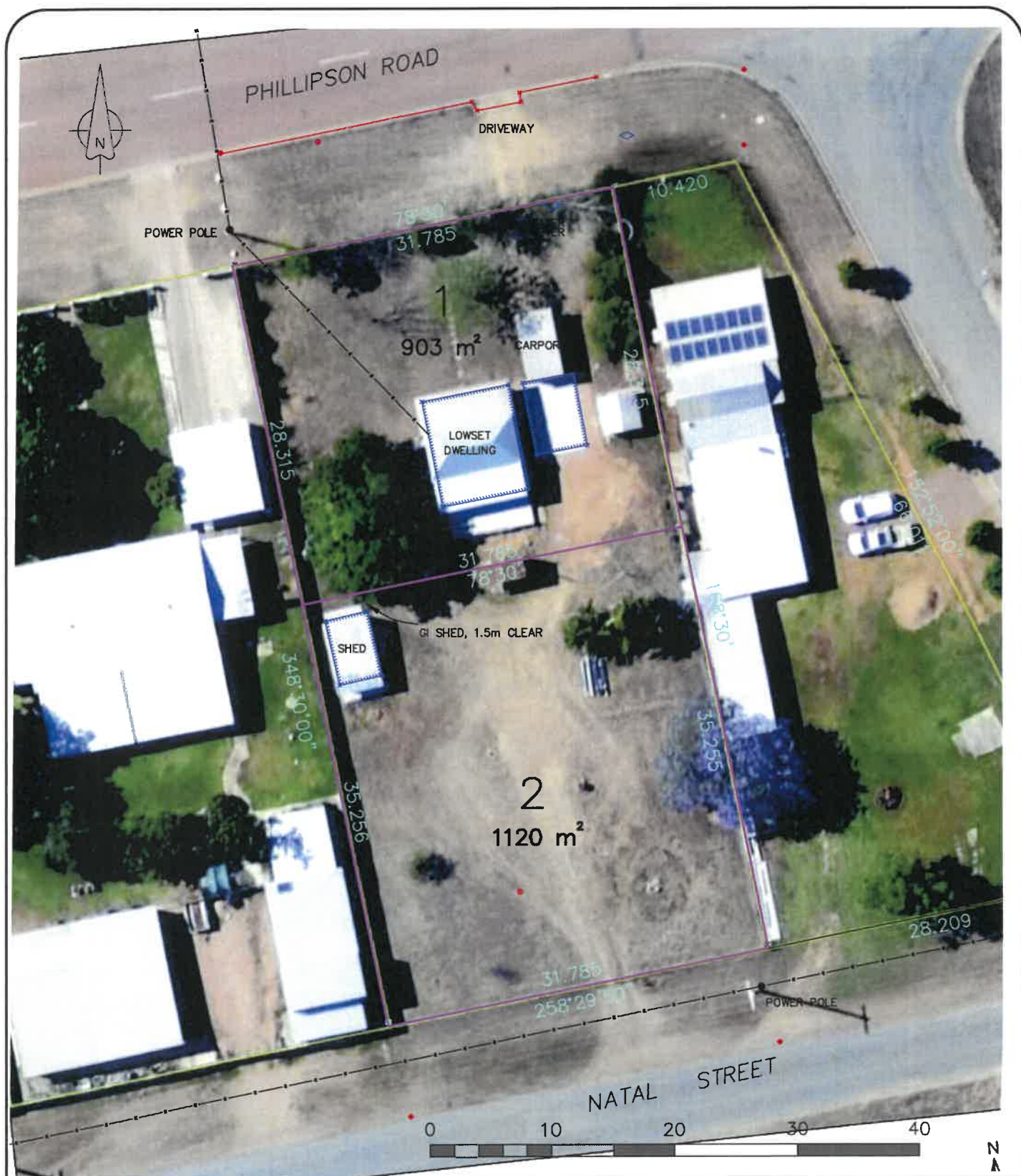
