

FEE EXEMPT WASTE

STUBLEY STREET LANDFILL & RESOURCE RECOVERY AREA

The Stubbley Street Landfill, located at 1 Stubbley Street, TOLL, is the region's main landfill. The smaller township landfills are covered in the next section.

Fee Exemptions apply to:

- Church or Charity Groups that offer donation bins
- Recyclables that are separated by type or can be placed in a recycling bin
- Waste resulting from a declared disaster, if so declared by the Disaster Management Group
- Scrap Steel, if separated and disposed to the scrap steel stockpile or a scrap metal recycling bin
- Any item that can likely be salvaged separately at the Weighbridge Gate House for re-sale. For example, if a person wanted to dispose of an old lounge. If the item was likely to re-sell, no landfill fee would apply.
- Waste Batteries (some restrictions may apply)
- Waste Motor Oil (restricted to 20 Litre maximum per visit)

Prohibited Items

- Hazardous materials including gas bottles, chemicals, paints
- Infectious and Clinical waste
- Untreated Sharps
- Explosives, ammunition and pyrophoric waste (potentially combustible)
- Cooking Oil, kerosene etc.
- Waste Motor Oil can be stored and recycled but not landfilled
- Batteries can be stored and recycled, but not landfilled
- Liquids and sludge's
- Stumps and logs greater than 300mm in diameter and limited to 1.0 metre in length
- Contaminated soil, except under permit
- Tyres, larger than a truck tyre
- Dead animals
- Radioactive waste



FEE EXEMPT WASTE

GREENVALE, PENTLAND & RAVENSWOOD LANDFILLS

Fees & Charges **DO NOT** apply to the Landfills located in Greenvale, Pentland and Ravenswood. The costs associated with maintaining these waste facilities, is facilitated by a Waste Utility Charge that applies to the rates of the relevant township residents. For this reason, waste is not accepted from commercial waste transporters, commercial operators or residents living outside the immediate district.

Township Landfill - Prohibited items

- Hazardous materials including gas bottles, chemicals, paints
- Infectious and Clinical waste
- Untreated Sharps
- Explosives, ammunition and pyrophoric waste (potentially combustible).
- Cooking Oil, Motor Oil, hydraulic oils etc.
- Batteries
- Liquids and sludge's
- Stumps and logs greater than 300mm in diameter and limited to 1.0 metre in length
- **Construction and Demolition waste** – including concrete, pavers, kitchens, bathroom, plasterboard, roofing materials, flooring, etc. (some exemptions may apply)
- **Commercial and Industrial waste** - (exemption for Local township businesses)
- Contaminated soil
- Treated timber
- Asbestos
- Tyres, larger than a truck tyre
- Offensive material such as quantities of meat, fish and dead animals.
- Putrescible Waste (Garbage Trucks) for Pentland and Ravenswood
- Radioactive Waste
